5 Year Limited Warranty

Interior/Closet Sliding Doors

The Sliding Door Co. warrants to the end consumer of our Sliding Doors named below the following:

1. The frames will be free from cracking, peeling, warping.. The warranty provided in this paragraph shall remain in effect for 5 years from the date of purchase.
2. All moving parts of the Sliding Door(s) will be free from any defect in material or workmanship.
3. This warranty covers the workmanship of the product and guarantees the highest quality materials and parts only. It is not intended to cover damage due to poor installation or misuse. Any damage to the product as the result of poor installation will nullify this warranty.

Each of the foregoing warranties is conditioned upon the normal use and care of the Sliding Door and includes all necessary parts, as determined by TSDC, and all labor costs. None of the warranties shall apply in the event of any damage caused by improper installation (if not installed by TSDC or it's recommended installers), misuse, abuse, alteration, improper maintenance fire or other casualty, negligence or any other cause beyond the control of TSDC. In addition, the warranty provided above shall not apply if the Sliding Door has been altered.

TSDC makes no representation or warranty with respect to condensation on the Sliding Door(s), since condensation does not indicate a defect but is a natural result of moisture in the environment and changes in temperature and humidity. This does not include condensation in between the panes of glass, when laminated glass is used only.

Purchaser's remedy against TSDC under this warranty shall be exclusively limited to either furnishing replacement parts for the Sliding door or furnishing a new Sliding door within the warranty period at the option of TSDC.

THE PROCEDURE FOR OBTAINING PERFORMANCE OF THE WARRANTY OBLIGATIONS IS AS FOLLOWS:

If you believe that the sliding door is defective according to the guidelines above, contact TSDC for evaluation. If the TSDC agrees that the Sliding door needs to be repaired or replaced, arrangements will be made as soon as practically possible.
